

Self-Declaration Regarding Exchange of Information

The purpose of this Self-Declaration is to create a trusted environment for all kinds of Users. Every User must sign this Self-Declaration to use the Services defined under the Terms of Use. This Self-Declaration will apply together with the Terms of Use of BAM.money, Inc. (“BAM.money”), in cases where this Self-Declaration is silent or contradicts with the Terms of Use, Terms of Use will apply.

This Self-Declaration is applicable starting from the day the User expresses its intent by electronic means to be a User of BAM.money and will continue to be in effect until the relationship between the User and BAM.money is terminated as defined under the Terms of Use.

“Information” means any and all information exchanged between the Users via the website, www.bam.money (“Website”).

The User hereby represents and warrants that all Information provided to BAM.money shall be true and correct; and the User shall hold BAM.money and **other affected Users** harmless from any and all liability, expenses or claims arising from the misrepresentation of Information including but not limited to untrue, incomplete or misleading Information.

The User further represents and warrants that it will not post or provide any information that knows (or ought to know) is false or misleading, provide false information about itself or the Assets, impersonate any other person, or otherwise attempt to mislead others about its identity, its affiliation with any person or entity, or the origin of any content, message, or other communication.

BAM.money has no control over the exchange of Information between the Users. However, BAM.money, while abiding by the confidentiality duty stated under the Terms of Use, retains the history of communications between Users. In line with the Terms of Use, **USER ACKNOWLEDGES AND AGREES THAT, SUBJECT TO APPLICABLE LAW AND ONLY FOR THE PURPOSES OF (I) COMPLYING WITH APPLICABLE LAWS, RULES, ORDERS, SUBPOENAS OR REQUESTS FOR INFORMATION BY GOVERNMENTAL OR REGULATORY AUTHORITIES OR SELF-REGULATORY ORGANIZATIONS, OR (II) FOR ANY OTHER PURPOSE DESCRIBED IN ANY AGREEMENT USER MAY HAVE WITH BAM.MONEY, BAM.MONEY MAY DISCLOSE THE INFORMATION EXCHANGED BETWEEN THE USERS USING THE WEBSITE, INCLUDING THOSE WHO ARE MARKED AS CONFIDENTIAL BY THE USER, TO ITS EMPLOYEES, REPRESENTATIVES, OFFICERS, DIRECTORS, AGENTS AND AFFILIATES, OR TO ANY GOVERNMENTAL OR REGULATORY AUTHORITY OR SELF-REGULATORY ORGANIZATION, OR TO ANY THIRD PARTY SERVICE PROVIDER.**

The language used by the Users should not be offensive and illegal, Users should refrain from using vague words/statistics/statements. Examples to these include but they are not limited to “probably”, “highly/not likely”, “often/generally”. However, if a User is providing vague Information, it is on the receiving User’s risk to rely on vague Information and BAM.money assumes no responsibility regarding such vague statements. Vague statements do not always constitute misleading Information, however, it **might** constitute misleading Information and lead to the responsibilities and indemnity obligations as stated herein.

BAM.money and any affected **User** or third party that the Information is related to reserve the right to take legal action against the User for any misleading and/or inaccurate Information disclosed by the User to BAM.money and other Users.

In the event that;

- (a) the Information provided by the User is material to the transaction between the Parties by taking into consideration the nature of the conversations, negotiations and transaction terms between the parties,
- (b) such Information is not accurate at the time of the communication between the Parties, and
- (c) the User was aware of such inaccuracies before the time of the finalization of the transaction,

the User warrants that it will notify the Counterparty by using the necessary means immediately but in any case 3 (three) days prior to the time of the finalization of the transaction between the Parties.

User acknowledges that BAM.money may, in its sole discretion, terminate, suspend or condition User's account due to material changes to the information provided by the User.

The User hereby represent and warrants that the User entered into this Self-Declaration of its own free will and in accordance with their own and state that it has not been induced to enter into this Self-Declaration by any statement, act or representation of any kind or character on the part of anyone except then itself.
